Copy of the Purchase Order(s) or Letter(s) of Award or Contract(s) of work alongwith completion certificate(s) or any other documentary proof thereof:

One Project of value of minimum Rs. 10 Crores having installation of minimum 500 Access Points (Both Indoor and Outdoor)

or

Two Projects of value of minimum 5 Crores of each project having installation of minimum 250 Access Points (Both Indoor and Outdoor) in each project

or

Four Projects of value of minimum 2.5 Crores of each project having installation of minimum 150 Access Points (Both Indoor and Outdoor)in each project".

2. Point no. 6 of Evaluation Criteria Column of the Table under SECTION V – SCHEDULE OF EVENTS AND EVALUATION PROCESS

The Applicant should have experience in successfully executing the Wi-Fi/Networking/Similar projects as specified above

One Project of value of minimum Rs.10 Crores having installation of minimum 500 Access Points (Both Indoor and Outdoor) – 10 marks

Two Projects of value of minimum Rs. 5 Crores of each project having installation of minimum 250 Access Points (Both Indoor and Outdoor) in each project – 7 marks

Four Projects of value of minimum Rs. 2.5 Crores of each project having installation of minimum 150 Access Points (Both Indoor and Outdoor) in each project- 4 marks

3. Point no. 3 of the Table at Annexure I - Eligibility Criteria

The applicant firm should have successfully completed/implemented at least:

One Project of value of minimum Rs. 10 Crores having installation of minimum 500 Access Points (Both Indoor and Outdoor)

Two Projects of value of minimum Rs. 5 Crores of each project having installation of minimum 250 Access Points (Both Indoor and Outdoor) in each project

or

Four Projects of value of minimum Rs.2.5 Crores of each project having installation of minimum 150 Access Points (Both Indoor and Outdoor) in each project

during the last five years.

4. The word 'Similar services/ Similar Work' used in the EoI can be read as Wi-Fi/Networking/Internet/ Telecom Services/Similar services
