Terms & Conditions:

1. All taxes as applicable will be charged in addition to above.
2. Tariff is liable to revision in future with notice period of three months.
3. Minimum subscription period of Web Hosting is one year and the entire annual charges shall be payable in advance.
4. After 1st year also, the annual charges shall be paid in advance against Performa Invoice/Invoice of ERNET India. In case of delay in payment by more than 3 months, interest on delayed payment @12% per annum may be charged for the delayed period.
5. The services to the user (user may also be read as user organization) will remain continue unless a written request from the user to discontinue the services with notice period of at least three months. ERNET India also reserves the right to discontinue the services in case of non-receipt of advance payment even before the expiry of 3 month notice period.
6. Notice period for disconnection of service will be three months.
7. Billing cycle may be aligned with Financial Year, for the convenience of both user and ERNET India.
8. VM would be given with basic Operating System (OS) configuration and user would then be required to configure add-ons/services.
9. User will be responsible for the migration of website from other cloud service provider to ERNET India cloud.
10. User will be responsible for the preservation of their Data. They may ensure necessary backup/remote replication of the same. ERNET India is not obligated to retain any User Data after the termination/ closure/ discontinuation of Cloud Account/ web hosting services.
11. ERNET India will provide backup services under Premium plan only. Standard plan user needs to maintain backup on their own.
12. To utilize the benefits of cloud computing, users need to ensure that applications hosted are cloud ready.
13. Users have to follow all rules prescribed from time to time for using their Cloud Accounts.
14. Users shall utilize the Cloud Services only for purposes that are legal, proper and in accordance with the Indian Cyber Laws. Authorized users shall not share their credentials or allow any other entity to use these services. Users should not interfere with or disrupt the integrity or performance of the ERNET India Cloud Services or attempt to gain unauthorized access to these services or any associated systems or networks.
15. The user will respect and follow all such sensitive and privacy guidelines issued by Government of India (GOI) from time to time.
16. The user will be solely responsible for any violation of information leakage or violation of privacy guidelines issued by GOI from time to time e.g. Aadhaar related personal information of individual.
17. Users are responsible for all information, data, text, software, music, sound, photographs, graphics, video, messages, files, attachments, or other materials, including images of instances that is created, transmitted, stored, or displayed by, from, or within user account including content of end user.
18. Users are responsible for maintaining the confidentiality of account username and password, and for all activities that occur under the account. Users should immediately notify the Cloud Management team of any unauthorized use of account, username or password.
19. Users will be responsible for maintaining appropriate security precautions for security and protection of all User Data.
20. For Shared Hosting, VM will be shared between customers. However, user site will be given unique address. Data uploading will only be through FTP or through user application. No server access will be given to the user at any point of time.
21. ERNET India Cloud shall be operated and managed as per security guidelines and policies issued by CERT-In (<http://www.cert-in.org.in/>). Security audit by the third party audit agency of sites should be completed prior to hosting of application on Cloud. A third-party audit security agency should be CERT-IN empanelled agency only. However, in case of exigencies, provision will be made to host sites without security audit for a limited period of time. This hosting will be at user's

risk. ERNET India will not be responsible for any issue arising as a result of hosting of an application prior to completion of audit.

22. ERNET India reserves the right to suspend/ terminate/ discontinue the services/ access to ERNET India Cloud Account in case of violation of any terms and conditions mentioned above.

23. **Termination of Hosting Services:** User shall comply to the following:

User acknowledges and agrees that upon expiration or termination of user Hosting Services, user must discontinue the use of the Hosting Services and relinquish the use of the IP addresses and server names assigned to the user in connection with Hosting Services, including pointing the Domain Name System (“DNS”) for user domain name(s) away from ERNET India’s servers. Prior to termination of the Hosting Services, user is responsible for moving their website or server content off ERNET India’s servers. ERNET India will not transfer or FTP user website or server content to another provider. If user fails to move their website or server content off ERNET India’s servers prior to cancellation/ discontinuation of services, ERNET India will not be responsible for any loss of data / content of user and will not be able to provide copy of such data / content to user.

Upon termination of the Hosting Services, all free (DNS) products provided as part of the Hosting Services will be cancelled/ revoked/ withdrawn.

Note for ERNET India for internal communication: DG ERNET India may consider to provide discount on the above tariff up to 40% on Standard Web Hosting Plans and 50% on the Premium Web Hosting Plans & on Additional resources to the users on case-to-case basis, if required.

Terms & Conditions:

1. All taxes as applicable will be charged in addition to above.
2. The tariff for ERNET India’s services is liable to revision in the future. Any revision in VSAT related charges of Government department’s like, Department of Space (DOS) and Department of Telecommunications (DoT) will be charged to the users from its effective date which may be even retrospective.
3. The payment for first year recurring charges shall be made in advance to ERNET India.
4. The annual recurring charges from second year shall also be paid in advance against Performa Invoice/Invoice of ERNET India. In case of delay in payment by more than 3 months, interest on delayed payment @12% per annum may be charged for the delayed period.

5. The minimum commitment period to retain the connectivity will be two years from the commissioning of the link.
6. The link can be surrendered by user after the minimum commitment period and with minimum 4 months' advance notice period in writing.
7. The link / services to the user will remain continue unless a written request from the user to discontinue the services with notice period of at least four months. However, ERNET India reserves the right to discontinue the services in case of non-receipt of advance payment even before the expiry of notice period.
8. Notice period for disconnection of service will be four months
9. The bandwidth may be decreased or increased as per the user/ site requirement on mutual agreement and accordingly its cost will change proportionally.
10. The link bandwidth will be provided as and when the transponder space segment will be available from Department of Space (DoS) to ERNET India.

Terms & Conditions:

1. All taxes as applicable will be charged in addition to above.
2. Minimum commitment will be for 1 year and the entire annual charges shall be payable in advance.
3. After 1st year also, the annual charges shall be paid in advance against Performa Invoice/Invoice of ERNET India. In case of delay in payment by more than 3 months, interest on delayed payment @12% per annum may be charged for the delayed period
4. Tariff is liable to revision in future with notice period of three months.
5. User shall have an option to migrate from one plan to other plan on the basis of written request after paying the difference.
6. Notice period for disconnection of service will be three months.
7. The services to the user will remain continue unless a written request from the user to discontinue the services with notice period of at least three months. ERNET India also reserves the right to discontinue the services in case of non-receipt of advance payment even before the expiry of 3 month notice period.
8. User account creation will be done by ERNET India. User can change their passwords.

Note for ERNET India for internal communication: The increase in tariff may be informed to the user institutions well in advance. However, DG ERNET India may give discount up to the previous tariff (i.e. by 25%) to the existing user institutions to retain them.

4. DNS Hosting Services

Tariff of DNS Hosting Services for user who desires to take only DNS Hosting services are as (w.e.f. 1.4.2024):

Note:

1. DNS Hosting services will be on complementary basis to the institutions/ users who are taking any other services from ERNET India, except Domain Registration services under ac.in, edu.in, res.in.
2. DNS Hosting service may be offered on special/discounted rates to the domain users (i.e. users under ac.in, edu.in, res.in) devised under Domain Registration services by Emerging Technology Division.
3. During domain registration through ERNET India's portal for ac.in, edu.in, res.in, the option to choose DNS hosting of NC Division (web Hosting) of ERNET India shall also be available and the name servers should be pre-filled in it for convenience of users.

Terms & Conditions:

1. All taxes as applicable will be charged in addition to above.
2. Tariff is liable to revision in future with notice period of three months.
3. The minimum subscription period shall be one year and the entire annual charges shall be payable in advance.
4. After 1st year also, the annual charges shall be paid in advance against Performa Invoice/Invoice of ERNET India. In case of delay in payment by more than 3 months, interest on delayed payment @12% per annum may be charged for the delayed period.
5. The services to the user will remain continue unless a written request from the user to discontinue the services with notice period of at least one month. ERNET India also reserves the right to discontinue the services in case of non-receipt of advance payment even before the expiry of one month notice period.
6. Notice period for disconnection of service will be one month.

Note for ERNET India for internal communication: ERNET India may continue to offer DNS Hosting services on complementary basis to the institutions/ users who are taking Web Hosting services from ERNET India. However, its records shall be maintained properly and updated on regular basis.
