Ministry of Health and Family Welfare(MOHFW) has floated a Tender for Request For Proposal (RFP)for selection of System Integrator for “SETTING UP OF E-CLASS ROOM INFRASTRUCTURE IN 50 MEDICAL COLLEGES” with Ref No: T-21016/77/2016-TM dated 12-05-2017. ERNET INDIA, An Autonomous Society under Ministry of Electronics and Information Technology, Govt of India, intends to participate in the above mentioned RFP. In this connection, ERNET INDIA invites Expression of Interest (EOI)for selection of consortium partner for pre-tender tie-up from reputed company / Organization for the comprehensive solution for Setting up of e-Classroom Infrastructure in 50 Medical Colleges for Ministry of Health & Family Welfare (MoHFW) exclusively as per the RFP with Ref No: T-21016/77/2016-TM dated 12-05-2017.

SCOPE OF WORK:

The proposed national network of medical colleges as per RFP with Ref No: T-21016/77/2016-TM dated 12-05-2017, will follow a hierarchical architecture having a Central HUB housing the DATA CENTER which has been designated as National Resource Centre (NRC) at SGPPI, Lucknow, UP. The NRC is to be networked with Seven Regional HUBs will be called as Regional Resource Centres (RRCs) located at different regions of the country which in turn will be networked with Medical Colleges (total of 42 in Nos) in that region. List of locations of NRC, RRCs and the Medical Colleges to be networked are mentioned in the RFP Ref No: T-21016/77/2016-TM dated 12-05-2017. The bidder should refer to the RFP for any clarifications and the terms binding on the prospective bidder for the RFP i.e. ERNET India in this case, is also binding in turn on the bidders for the EOI. Successful Bidder has to carry on the works on behalf of ERNET India as back to back arrangements.

MAJOR ACTIVITIES INVOLVED IN THE TENDER ARE:

Establishment of the proposed national network of medical colleges as per RFP with Ref No: T-21016/77/ 2016- TM dated 12-05-2017 will involve the following activities:

1. Supply, Installation, Testing and Commissioning, Training and Operations of requisite equipment for e-Classroom and Maintenance for five years from date of commissioning strictly as per the RFP with Ref No: T-21016/77/2016-TM dated 12-05-2017.
2. Integration of the Network with Centralized Infrastructure at National Resource Centre (NRC) which is at SGPPI, Lucknow, UP.
3. Provide various services like video conferencing, webcasting, web streaming, archival of live lectures & e-contents, maintenance of all equipment etc. to be provided by the Agencies during the empaneled period.
4. The successful bidder will do the coordination with NIC regarding NKN connectivity for smooth implementation and utilization of NKN connectivity/network.

EVALUATION PROCEDURES:

Following procedure shall be adopted in evaluating the proposals:

1. The bids submitted in response to this EOI having the documents related to the “Prequalification criteria” would be evaluated by ERNET India at the first stage.
2. ERNET India will share tender details (Annexure-1) only with the prospective bidders who procure the EOI Document with a Fee of Rs.2,000/- in the form of a Demand Draft in favour of “ERNET India” and payable at New Delhi. They have to submit the Documents in support of their Prequalification in a separate Sealed Cover. The “Technical Proposal” (in Seal Cover) should be as per the tender requirements and must be complied with its Technical specifications and techno-commercial Terms & Conditions on back to back basis.

3. Both the Sealed Covers/Envelopes covering i) **Documents in support of Pre Qualifications** and ii) Technical Proposal should be separately sealed in a separate Bigger Envelope.
4. ERNET India may ask for detailed presentation on the offered solution and implementation methodology during evaluation of the Technical proposal submitted by pre-qualified parties.
5. The technically qualified bidder(s) will be asked to submit the EMD to ERNET India as per ERNET India's EMD format (Annexure-A) and Financial Proposal (**in 3 Days** after evaluation of Technical Proposals and hence are required to be prepared for submission of the Financial Bid along with the EMD in accordance with the Bid Formats of the Tender/EOI) in separate sealed envelopes marked "EMD" and "Financial Proposal" respectively in 3 Days. Bidders are requested to submit their final quote and under no circumstances they will be allowed any upward revision of prices quoted in the Financial Proposal. Refundable(after the completion of due process of evaluation/completion of work order if offered) EMD of Rs. 10,000,000 (Rupee One Crore only) shall be submitted in the form of Demand Draft (DD) /Bank Guarantee in favour of ERNET India" payable at New Delhi. The EMD should be valid for a period of 235 days from the submission of EOI. EMD will be refunded to the unsuccessful bidders within 30 (Thirty) days of completion of selection process. The format for EMD is placed at Annexure-A of the EOI.
6. In the Final Stage of evaluation, ERNET India will open and evaluate the financial proposals of those bidders, who have submitted the requisite EMD. The bidder whose bid price is lowest (L1 bidder) will be selected as consortium partner. ERNET India will participate in the said tender as lead bidder in consortium with the selected bidder (L1 bidder) based on the prices discovered. This will be done with ERNET India's loaded margins for the tender.

Note:

1. In case turn over in foreign currency, the value should be shown in INR as per the conversion rate prevailing at the time at which the balance Sheet were prepared.
2. ERNET India reserves the right to accept or reject the bids submitted against this EOI, of any of the participants without assigning any reasons thereof. The decision of ERNET India is final and binding on the participants.
3. The evaluation committee will determine whether the financial proposal/ information are complete in all respects and the decision of the evaluation committee shall be final.
4. Parties interested to work with ERNET India on exclusive basis and agreeing to the evaluation procedure with EMD of Rs. 100,00,000 (Rupee One Crores only) may submit their proposal against Expression of Interested (EOI) available on ERNET India's website (<http://www.eis.ernet.in>) & CPP Portal.
5. Technically Qualified Bidders are required to submit the Commercial Bids/Financial Proposals in 3 Days after evaluation of Technical Proposals and hence are required to be prepared to submit the Financial Bid/proposal along with the EMD.
