**Shortlisted candidate will be informed by return email indicating tentative time enabling them to attend the interview through video conferencing on prior to the date of interview. Candidate must have good internet facility and available on mentioned mobile number.**

2. The appointment against the above mentioned positions shall be purely on contract basis on consolidated pay for a fixed duration and against specific approved projects.
3. Upon Selection of candidate, the candidates would be appointed initially for a period of one year, which may be extended upto a maximum of project duration or curtailed based on the performance and requirement of the project. Further, incumbents so engaged under a particular project can be transferred to another project during or on completion of the project in which he/she originally deployed, in the organizational interest.
4. Candidates presently working in a Government/ Semi-Government / Public Sector Undertaking / Autonomous Body are required to submit a ‘No objection Certificate’ from their present employer at the time of interview/ test etc., if called for, failing which they will not be permitted to attend the interview.
5. The date for determining the upper age limit, qualifications and /or experience shall be date of interview. Person below the age of 18 years are not eligible for consideration of selection.
6. Candidates shall produce proof of documents in support of educational qualification, experience, age etc. for verification before appearing in the selection process i.e. interview/test etc.
7. Experience means post qualification and it will be counted after attaining minimum qualification as prescribed above.

8. Essential qualifications as prescribed above should be a full time regular course(s) from AICTE/UGC approved/recognized University/Deemed University/Institutes.
9. Monthly remuneration will be subdivided/ bifurcated as per applicable finance norms of ERNET India.
10. Reservation and relaxation as admissible for SC/ST/OBC/EWS will be applicable as per the Govt. of India norms, as applicable to ERNET India.
