- **Qualification:** B.Tech / B.E / MCA / M.Sc or equivalent degree in Electronics and Communication/Computer Science/Information Technology.
- **Experience:**
 - B.Tech / B.E / MCA / M.Sc or equivalent: At least 6 years of post-qualification experience in Electronics and Communication / Computer Science/Information Technology.
 - M.Tech / M.E or equivalent: At least 4 years of experience in Electronics and Communication/Computer Science/Information Technology.
- Candidate having interest on Computer Networks, Optical Communication, Quantum Communication etc., having sufficient interest/knowledge in the relevant area will also be considered.
- **Desirable:** Candidates having exposure to Quantum Technologies / Quantum Key Distribution (QKD).

For Project Engineer (Level -1)

- B.Tech / B.E / MCA / M.Sc or equivalent degree in Electronics and Communication/Computer Science/Information Technology.
- Candidate having interest on Computer Networks, Optical Communication, Quantum Communication etc., Fresher having sufficient interest / knowledge in the relevant area will also be considered.
- **Desirable:** Candidates having exposure to Quantum Technologies / Quantum Key Distribution (QKD).

Shortlisted candidate will be informed by email indicating the date and time of interview enabling them to attend the interview through either physical or online mode.

3. The appointment against the above mentioned positions shall be purely on contract basis on consolidated pay for a fixed duration and against specific approved projects.
4. Upon Selection of candidate, the candidates would be appointed initially for a period of two years, which may be extended up to a maximum of project duration or curtailed based on the performance and requirement of the project. Further, incumbents so engaged under a particular project can be transferred to another project during or on completion of the project in which he/she originally deployed, in the organizational interest.
5. Candidates presently working in a Government / Semi-Government / Public Sector Undertaking / Autonomous Body are required to submit a 'No objection Certificate' from their present employer at the time of interview/ test etc., if called for, failing which they will not be permitted to attend the interview.
6. The date for determining the upper age limit, qualifications and / or experience shall be date of interview. Person below the age of 18 years is not eligible for consideration of selection.
7. Candidates shall produce proof of documents in support of educational qualification, experience, age etc. for verification before appearing in the selection process i.e., interview / test etc.
8. Experience means post qualification and it will be counted after attaining minimum qualification as prescribed above.
9. Essential qualifications as prescribed above should be a full-time regular course(s) from AICTE/UGC approved / recognized University / Deemed University / Institutes.
10. Monthly remuneration will be subdivided/ bifurcated as per applicable finance norms of ERNET India.
11. Reservation and relaxation as admissible for SC / ST / OBC / EWS will be applicable as per the Govt. of India norms, as applicable to ERNET India.
12. Candidate belonging to reserved categories should produce the certificates at the time of written test / skill test / interview etc., if called for, issued by competent authority in the prescribed format as stipulated by Government of India, failing which such candidates will not be allowed to attend the interview / selection test against reserved posts and will not be allowed to claim the relaxations applicable in case of reserved categories.
