2. Please note the following terms and conditions while submitting the offer:-
 - (i) Price should be quoted in the "Offer Form" enclosed only at **Annexure II.**
 - (ii) GST as applicable will be charged extra.
 - (iii) Earnest money (E.M.) is to be deposited @ Rs. 5,000/- along with each offer. Offers received without requisite E.M. will be summarily rejected.
 - (iv) The offer should be valid for acceptance for 90 days from the date of opening of bids.
 - (v) E.M. will be refunded / settled on successful award of the contract.
3. If any dispute arises between the successful bidder and its manpower at the time of loading/unloading of items/ material, the same will be settled by the successful bidder and the workers engaged by it themselves; ERNET India does not owe any responsibility or liability whatsoever it may be in this connection.
4. **Earnest Money Deposit:** Bidders are required to submit the Earnest Money Deposit@ Rs. 5,000/- in offer form and submit in the form of pay order/ bank demand draft in favor of ERNET India payable at New Delhi from a Scheduled Bank. 7. Evaluation of bids for deciding successful bidder shall be done on the basis of total highest **Lumpsum price** quoted for all the items (whole lot) together as listed in **Annexure II**. List of items/ material are attached as **Annexure I**. Partial quoted bid will liable to be rejected. The bidder shall fill in the price (Total price of all the items) both in words and figures while quoting the **LUMPSUM Price**. If there is a discrepancy between words and figures, the amount in words will prevail. The bidders are also advised not to erase or overwrite the figures, etc. otherwise the bids may not be considered
8. No item(s) once disposed to the successful bidder shall be taken back by ERNET India on any condition whatsoever.
9. Bidder must enclose certificate of being authorised as **e-waste dismantler/ recycler**, certificate for registration/incorporation, copy of PAN Card alongwith the bid. In case of GST registered bidder, copy of GST Registration certification is required.
10. ERNET India reserves the right to accept or reject any bid or cancel the tender proceedings without assigning any reason whatsoever.
11. 12. Bids delayed/ late on any account, Postal or otherwise, will be summarily rejected. ERNET India will not be responsible for any loss in transit or postal delay.
13. The bidders shall keep their offer open for acceptance for a period of 90 days from the date of opening of the bids. If bidder does not accept it, or modifies the terms and conditions thereof in a manner not acceptable to the ERNET India or bidder fails to observe or comply with this stipulation, the amount deposited as Earnest Money (E.M.) for the due performance shall be forfeited.
