3. The appointment against the above mentioned positions shall be purely on contract basis on consolidated pay for a fixed duration and against specific approved projects.

4. Upon Selection of candidate, the candidates would be appointed initially for a period of one year, which may be extended upto a maximum of project duration or curtailed based on the performance and requirement of the project. Further, incumbents so engaged under a particular project can be transferred to another project during or on completion of the project in which he/she originally deployed, in the organizational interest.

5. Candidates presently working in a Government/ Semi-Government / Public Sector Undertaking / Autonomous Body are required to submit a ‘No objection Certificate’ from their present employer at the time of interview/ test etc., if called for, failing which they will not be permitted to attend the interview.

6. The date for determining the upper age limit, qualifications and /or experience shall be date of interview. Person below the age of 18 years are not eligible for consideration of selection.
