  - (iii) Work will be awarded to each of the successful bidders (max 10 in each part) equally with a condition that L1 bidder will be awraded 10% over and above all other successful bidders who agrees to match the L1 price

Calculation of work awarded will be done over the period of one year subject to availability of sufficient work order from the client(s). The same will be done on the nearest approximation basis.

#### 8. Pre-Bid Meeting:

- (i) ERNET India shall organize a Pre-Bid meeting on the queries submitted (by stipulated dat & Time) by the Bidders on the scheduled date and time at ERNET India. ERNET India may incorporate any changes in the tender based on acceptable suggestions received during the interactive Pre-Bid meeting. The decision of the ERNET India regarding acceptability of any suggestion shall be final in this regard and shall not be called upon to question unde any circumstances. Only two persons for each intending bidder's organization, who will buy the tender, will be allowed to attend the Pre Bid Meeting. The Bidder will have to submit the photocopy of the receipt of payment made against tender fee at the time of Pre-Bid conference.
- (ii) Response/reply to Queries/clarifications received within time frame as stated in the tende shall be uploaded on CPP portal/ERNET India website. No reply in this regard shall be sen to individual bidder. Bidders are advised to keep visiting CPP Portal/ERNET India Website to get the details in this regard, if any, before submission of their bids on the due date/time.
- (iii) ERNET India may, for any reason, whether at its own initiative or in response to a clarification requested by prospective bidders, modify the Tender Document by an amendment. The same will be posted on CPP portal/ ERNET India's website.

#### 9. Earnest Money Deposit (EMD)

- (a) Each quotation must be accompanied by Earnest Money Deposit (EMD) Rs.10 Lakhs and shall be in the form of Demand Draft/Pay Order/Bank Guarantee of any Nationalized Bank taken in the name of ERNET India, New Delhi. EMD in the form of Bank Guarantee should be valid minimum for a period of 225 days from the original due date of the quotation Ouotations received without Earnest Money Deposit are liable to be rejected.
- (b) Any tender not accompanying with EMD and tender fee (if tender document is downloaded from website) will be considered non responsive and rejected.
- (c) The Bid security (EMD) can be forfeited at the discretion of ERNET India on account of one or more of the following reasons:
  - The Vendor(s) withdraws their Bid during the period of Bid validity
  - Vendor(s) does not respond to requests for clarification of their Bid
  - Vendor(s) providing false information
- (d) If any bidder refuses to match his quote with L1 bidder, that bidder will be treated unsuccessful. EMD of unsuccessful bidders will be returned after completion of tender process (technical and financial bids). Award of Rate Contract to successful bidders will no be a condition for return of EMD of unsuccessful bidders. No interest will be payable by ERNET India on the Earnest Money Deposit.
- (e) Successful Bidder have to sign written rate contract agreement and submit Security Deposit of Rs.10 Lakhs in the form of Demand Draft/Pay Order/Bank Guarantee of any Nationalized Bank taken in the name of ERNET India, New Delhi, within a period of 15 days of issuing of

Rate Contract. The agreement and Security Deposit will be valid up-to 3 years and further extendable for 2 more years or up-to validity period of Rate Contract, as the case may be.

- (f) EMD of the successful bidder will be forfeited and rate contract will be cancelled if
  - If the vendor(s), who has/have been selected for rate contract, fails to sign a written agreement for rate contract with in specified time period or
  - fails to furnish the required security deposit with in specified time period
- 10. The Bids must reach the undersigned on or before the due date, i.e., on: 30.09.2015 by 3.00 p.m. Bids received after the due date & time is liable to be rejected. In the event of due date being a public holiday or declared Holiday for Central Government offices, the due date for submission of the bids will be the following working day at the appointed time & venue.
- 11. The rates should be quoted in Indian Rupees. All prices shall be fixed and shall not be subject to escalation of any description. The rates must be quoted as per the Performa provided in Annexure—II and submitted in a sealed cover subscribed as "Commercial Bid for Development/Renovation / migration of websites to CMS based website to make it responsive and WCAG 2.0 &/or GIGW compliant. Price comparison will be made independently for each group as per items specified in Annexure—II.
- 12. The bidder is required to sign and stamp the **Service Level agreement (SLA)** placed at Annexure III.
- 13. The bidders/ firms are required to submit an undertaking that "they have understood the requirement and also agree to the SLA terms as per Annexure III attached with the enquiry letter". This undertaking must be submitted in a technical part of the bid. In case their undertaking is not submitted, commercial bid submitted in separate sealed cover will not be opened for consideration.

### 14. Incomplete quotations are liable to be rejected.

- 15. Bidder shall sign all pages of terms & conditions, solution architecture along with quotation. All changes, alterations, corrections in the bid shall be signed in full by the person(s) signing the bid with date.
- 16. In case of any discrepancy between rates mentioned in figures and words, the latter shall prevail.
- 17. ERNET India may waive any minor informality or non-conformity or irregularity in a bid which does not constitute a material deviation, provided such waiver does not prejudice or affect the relative ranking of any Bidder
- 18. ERNET India reserves the right to accept or reject any bid or cancel the bid proceedings without assigning any reason whatsoever
- 19. (i) ERNET India will empanel maximum 10 bidders in each group (Part-1 to 5) for responsive website development/ migration to CMS based website conforming to WCAG / or and GIGW subject to that L2-L10 bidder will have to match the price of L1.
  - L1 to L10 price in each group (part-1 to 5 at Annexure -II) will be identified separately.
  - (ii) After determination of lowest value bid in each part(s), all the responsive, eligible and technically qualified vendor(s) shall be asked to match the lowest value (L1) bid. The pool

of vendor(s) matching best value (L1) bid will be created separately for each of the part (i.e. Part-1-to-5). In case there are less than 10 response / eligible bidders in any part(s) then empanelment of vendor(s) will be done for lesser number(s) of valid bids also

(iii) Work will be awarded to each of the successful bidders (max 10 in each part) equally wit a condition that L1 bidder will be awarded 10% over and above all other successful bidders who agrees to match the L1 price

Calculation of work awarded will be done over the period of one year subject t availability of sufficient work order from the client(s). The same will be done on the neares approximation basis.

- 20. No commitment of any kind, contractual or otherwise shall exist unless and until a formal writte contract has been executed by or on behalf of ERNET India. ERNET may cancel this tender/ o rate contract at any time prior to a formal written contract being executed by or on behalf o ERNET India.
- 21. Being an empanelment tender for Rate Contracting, ERNET India may terminate the Rate Contracting by giving 30 days advance notice of termination without assigning any reason whatsoever.
- 22. The Commercial evaluation shall include all costs and all taxes and duties applicable to th vendor(s) as per law of the Central/ State Government/ Local Authorities, and the Eligibility criteria specified in the bidding documents shall only be applied

#### 23. Indemnity

The successful bidder(s) shall indemnify the ERNET India/End-user departments against all thin party claims of infringement of patent, trademark/copyright or industrial design rights arising fron the use of the supplied items and related services or any part thereof. ERNET India/End-use department stand indemnified from any claims that the bidder's manpower may opt to have towards the discharge of their duties in the fulfillment of the purchase orders. ERNET India/End user department also stand indemnified from any compensation arising out of accidental loss o life or injury sustained by the bidder's manpower while discharging their duty towards fulfillmen of the rate contract and purchase orders. The bidder shall solely responsible for any damage, loss or injury which may occur to any property or to any person by or arising out the execution of the works or temporary works or in carrying out of the contract otherwise than due to the matter referred to in this agreement hereinbefore. The bidder would ensure for observance of all labor and other laws applicable in the matter and shall indemnify and keep indemnified the ERNET/its customers against the effect of nonobservance of any such laws.

#### 24. Force Majeure

If at any time, during the period of contract, the performance in whole or in part by either party of any obligation under the project is prevented or delayed by reasons of any war, hostility, acts of public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics quaranting restrictions, strikes, lockouts or acts of God (hereinafter referred to as "events"), provided notice of happenings of any such event is duly endorsed by the appropriate authorities/chamber of commerce in the country of the party giving notice, is given by party seeking concession to the other as soon as practicable, but within 21 days from the date of occurrence and termination thereof and satisfies the party adequately of the measures taken by it, neither party shall, by reason of such event, be entitled to terminate the contract, nor shall either party have any claim for damages against the other in respect of such nonperformance or delay in performance, and deliveries under the contract shall be resumed as soon as practicable after such event has come to

an end or ceased to exist and the decision of the purchaser as to whether the deliveries have so resumed or not, shall be final and conclusive, provided further, that if the performance in whole or in part or any obligation under the contract is prevented or delayed by reason of any such event for a period exceeding 60 days, the purchaser may at his option, terminate the contract.

#### 25. Termination For Default

- i) Default is said to have occurred
  - a. If the bidder fails to deliver any or all of the services within the time period(s) specified in the purchase order or any extension thereof granted by ERNET India.
  - b. If the bidder fails to perform any other obligation(s) under the agreement.
- ii) If the bidder, in either of the above circumstances, does not take remedial steps within a period of 30 days after receipt of the default notice from ERNET India (or takes longer period in-spite of what ERNET India may authorize in writing), ERNET India may terminate the purchase order in whole or in part. In addition to above, ERNET India may at its discretion also take the following actions:

ERNET India may get work from another bidder, upon such terms and in such manner, as it deems appropriate, and the defaulting bidder shall be liable to compensate ERNET India for any extra expenditure involved towards goods and services to complete the scope of work in totality and 10% of the total value of purchase order as cancellation charges through invocation of Performance Security.

iii) ERNET India may at any time terminate the empanelment/purchase order by giving 30 days written notice to the bidder, without any compensation to the bidder, if the bidder becomes bankrupt or otherwise insolvent

#### 26. Arbitration

- i) In case any dispute or difference arises out of or in connection with or the carrying out of works (whether during the progress of the works or after their completion & whether before or after the termination, abandonments or breach of contact) except as any of the accepted matters, provided hereunder, the parties hereto, shall first endeavor to settle such disputes of differences amicably.
- ii) If both the parties fail to reach such amicable settlement, then either party (ERNET India or Contractor) may (within 20 days of such failure) give a written notice to the other party requiring that all matter in dispute or difference be arbitrated upon. Such written notice shall specify the matters which are in difference or differences of which such written notice has been given and no other shall be reoffered to the arbitration of a single arbitrator, to be appointed by both the parties or in case of disagreement as to the appointment of a single arbitrator, to that of two arbitrators, one to be appointed by each party or in case of said arbitrators not agreeing then, to the umpire to be appointed by the arbitrators in writing before entering upon the references. Provisions of Indian Arbitration & Conciliations Act, 1996 or any statutory modification or reenactment thereof and rules framed there under from time to time shall apply to such arbitration.
- iii) Venue of arbitration shall be New Delhi.
- iv) The arbitrators or arbitrators appointed under this Article shall have the power to extend the time to make the award with the consent of parties.
- v) Pending reference to arbitration, the parties shall make all endeavors to complete the work in all respect. Disputes, if any, will finally be settled in the arbitration. Tender Enquiry No.: EI-D-Tech/51/0095/2015-PD&OA dated 23.08.2015
- vi) Upon every or any such references to the arbitration, as provided herein the cost of and incidental to the reference and Award respectively shall at the discretion of the arbitrator, or the umpire, as case may be.

vii) The award of arbitrator or arbitrators, as the case may be, Shall be final and binding on the parties. It is agreed that the Contractor shall not delay the carrying out of the works by reason of any such matter, question or dispute being referred to arbitration, but shall proceed with the works with all due diligence. The Purchaser and the Contractor hereby also agree that arbitration under this clause shall be the condition precedent to any right of action under the contract except for as provided for in the Tender.

## 29. Applicable Law

- i) The bidder shall be governed by the laws and procedures established by Govt. of India, within the framework of applicable legislation and enactment made from time to time concerning such commercial dealings/processing.
- ii) All disputes in this connection shall be settled in Delhi jurisdiction only.
- iii) ERNET India reserves the right to cancel this tender in part of full or modify the requirement without assigning any reasons. ERNET India will not be under obligation to give clarifications for doing the aforementioned.
- iv) ERNET India also reserves the right to modify/relax any of the terms & conditions of the tender.
- v) ERNET India, without assigning any further reason can reject any tender(s), in which any prescribed condition(s) is/are found incomplete in any respect.
- vi) ERNET India also reserves the right to award work order on quality/technical basis, which depends on quality/capability of the system and infrastructure of the firm. Bidder(s) are, therefore, directed to submit the tender carefully along with complete technical features of the products/systems as well as other documents required to access the capability of the firm.

## 30. Performance Bank Guarantee (PBG)

Bidder has to submit PBG of 30% of total cost of purchase order for web site development or renovation, within 10 days of award of purchase order, valid for one year. Vendors will be empaneled for rate contract separately as per L1-L10 in every part mentioned in Annexure-II.

The PBG equivalent of AMC cost will be submitted every year, in case the AMC is being awarded / or renewed, at the beginning of start of AMC, to the customer, whose website will be given for AMC, directly.

#### 31. Deliverables

- (i) Delivery Period
  - The **Development/ Migration/ Renovation of website** at test site/ staging server and installation / commissioning in production site as per following schedule:

- Delivery start date is defined as the date of receipt of PO and all relevant contents / material for website from customer.
- This delivery period mentioned in table 30 (i) above will be applicable for upto 25 websites. For more websites, the similar delivery period will be given for block of upto 25 websites.
- Modifications/testing of website as and when require will continue till the end of warranty period.

#### Completion date is defined as

- Installation report along with Acceptance Test Report (ATR) countersigned by user shall be submitted within 10 days from Date of Delivery.
- Security audit report by CERT-in empaneled agency
- Web accessibility (WCAG 2.0), responsiveness &/ or GIGW compliance validation by an independent organization (ie STQC) / GreenCloude etc or authentic tools like RPT, Appscan, W3C recommended Open Tools like A-Checker, WAVE etc
- Any delay by the supplier in the performance of delivery of items or/and non compliance of SLA shall render the supplier liable to any or all of the following sanctions:
  - (i) Forfeiture of its Performance Bank Guarantee (PBG),
  - (ii) Imposition of liquidated damage as per para 34 below or/and
  - (iii)Cancellation of the purchase order for default.
- Any delay in the supplies/installation would be reported to ERNET India and specific prior approval for delay with justification would be taken on case-to-case basis.
- Vendor/ bidders have to submit the basic design architecture and flow of website to an organization/customer/ ERNET for their acceptance before development.
- Delay due to non-readiness of the website contents from Organization or delay in finalization of website design / architecture or due to any natural disaster will not be considered for liquidated damage.
- The attachment of documents in any format like PDF/ Word/ scanned will not be counted as webpages for the purpose of accounting the cost of total website pages.
- Vendor has to supply the software code in CDs along with website. Customer whose website will be developed/renovated will be owner of software code and bidder will have no right on the developed code/ website

## (ii) Criteria for Acceptance

The report on website completion shall be delivered to ERNET/ customer within 15 days of completion of website. As website will be deemed to have met all acceptance criteria when:

- Satisfactory completion certificate from the customer is submitted
- Security Audit certificate by CERT-in empaneled agency is submitted
- It is certified WCAG2.0(accessibility) and / or GIGW compliant and responsive by an independent organization/ certification tool

## 32. Warranty:

The comprehensive warranty of the website shall be for a period of one year from the date of acceptance of the website by respective organization whose website is developed/ or by ERNET India. The Warranty shall include on-site comprehensive free maintenance, updating website if required. The defects/bugs, if any shall be attended to on immediate basis but in no case any defect should prolong for more than 24 hours. Attending calls in case of any hacking, non-functional of website due to coding issues etc will be also be Governed by SLA

#### 33. AMC:

All the prospective bidders have to quote for AMC of website, for a period of one year after the completion of warranty period. Bidder has to quote AMC cost in percentage of the cost of items quoted and that percentage will be applicable to each subpart. It is however, clarified that AMC price of one year would be included for price comparison and in deciding L1-L10 bidder. But the AMC prices will be valid for 4 years after warranty.

A separate PO for AMC will be issued on year to year basis or for a period upto 4 years directly by organization/customer, if required, after satisfactory warranty period.

#### Scope of AMC:

Maintenance, updating/ upgrading website as and when required. The defects/bugs, if any shall be attended to on immediate basis but in no case any defect should prolong for more than 24 hours. Attending calls in case of any hacking, non-functional of website due to coding issues etc will also be governed by SLA.

#### 34. Liquidated Damages:

If the supplier fails to deliver the website with respective compliance, testing and security audit within the period specified in the purchase order, ERNET India shall without prejudice to its other remedies, deduct as liquidated damage 2% of the price of the delayed products/website for every week subjected to maximum of 10%. If the company failed to complete the work of project and declared defaulted if it delayed beyond 5 weeks, then PBG will also be forfeited and the firm / company shall be black listed for future business with ERNET India or disqualified for the consideration of their bids in future.

## 35. Payment Terms:

- (a) 100% Payment will be made after completion of satisfactory work and acceptance of developed/renovated website by ERNET's concerned officer/ customer.
- (b) The payment shall be made by cheque/RTGS/NEFT after submission of a pre-receipted bill in the name of Registrar & CPO, ERNET India, 10<sup>th</sup> Floor, Jeevan Prakash Building, 25, KG Marg, New Delhi 110 001
- (c) In case of AMC, payment will be made directly by the customer whose website will be given for AMC
- (d) AMC payment will be made after satisfactory completion of services, on yearly basis.

#### 36. Purchase order (PO)

Purchase order will be issued separately for specific website as per requirement specified in Annexure-2 at time to time as per rate contract and empanelment. Bidder has to submit PBG of 30% of total cost of each PO within 15 days of the placement of purchase order.

## 38. Eligibility Criteria

- Bidder should have the Average Annual turnover of Rs5.Cr (Rupees Five Crore only) per (vi) year for last 2 years (FE 2013-14, 2014-15) from software development/ IT services/website development
- Submission of Valid EMD (vii)
- Bidder should have given clause-by-clause compliance for the technical specifications/ (viii) requirements of the website in their technical bids.
- Comply all Terms & Conditions of the tender (ix)

#### 1. Understanding of requirement:

To develop or revamp (as per the requirement) the existing website of the organization:
