2. 3. The appointment against the above mentioned positions shall be purely on contract basis on consolidated pay for a fixed duration and against specific approved projects.

Upon Selection of candidate, the candidates would be appointed initially for a period of one year, which may be extended upto a maximum of project duration or curtailed based on the performance and requirement of the project. Further, incumbents so engaged under a particular project can be transferred to another project during or on completion of the project in which he/she originally deployed, in the organizational interest.

5. Candidates presently working in a Government/ Semi-Government / Public Sector Undertaking / Autonomous Body are required to submit a ‘No objection Certificate’ from their present employer at the time of interview/ test etc., if called for, failing which they will not be permitted to attend the interview.

6. The date for determining the upper age limit, qualifications and /or experience shall be date of interview. Person below the age of 18 years are not eligible for consideration of selection.

7. Candidates shall produce proof of documents in support of educational qualification, experience, age etc. for verification before appearing in the selection process i.e. interview/test etc.
